The position of Provost at Zayed University is equivalent to the position of *President* in American universities although the Minister of Higher Education and Scientific Research is the President of all public universities and colleges. President, The University of Toledo, 2001 - 2006.

University of Toledo (UT), a comprehensive metropolitan research university located in Toledo, Ohio, serves 21,000 undergraduate and graduate students. In 2006, helped lead the University in its merger with the Medical University of Ohio to become the third largest university in Ohio in terms of budget and research and one of only 16 public universities in the nation with the broad range of professional schools that resulted from the merger.
